## **Declaration and Commitment of a Candidate for Studies / Continuing student**

- 1. I, the undersigned, hereby request to be accepted/continue as a student at Bar-Ilan University. I know that registration fees, entrance exam fees, etc. are not refunded.
- 2. As part of my application to be admitted to study at the university, I gave the university personal details and such, which are required for checking candidacy for the university and/or for the purpose of studies at the university and for the purpose of contacting me, and I was also given the option to provide, according to my choice, additional details, which I am under no legal obligation to transfer, for optional purposes such as scholarships, adjustments, etc. I was informed that the details I provided will be kept in the university's databases. I declare and warrant that all the details I have provided are correct and complete, and agree that the university may conduct an inspection and obtain details for the purpose of verifying the truth as well as take disciplinary measures or others, including canceling registration, stopping studies and canceling eligibility for a scholarship retroactively, in the case of providing false and/or misleading data.
- 3. I undertake to keep up-to-date with all the university's instructions and regulations, which are published on the website on the website <a href="www.biu.ac.il">www.biu.ac.il</a> as well as in the information sheets that the university issues, and in messages sent to students, including by e-mail. I know that the instructions, regulations and notices are binding and I undertake to abide by them, throughout all my years of study at Bar-Ilan University.
- 4. I know that the format of the studies, including exams, will be determined by the university authorities accordingly to the academic requirements, to the provisions of the law, to the circumstances related to the Corona crisis and constraints arising from this and that the studies and exams may take place in physical presence, online, in combination between the two, or in any other suitable way, and often using means of appropriate technologies, as determined by the university.
- 5. I undertake to pay the tuition fees, mandatory student payments and related payments, and any amount that will be paid to me in accordance with the university's instructions, on time. I agree that lags in the payment(s) will incur linkage differences and arrears fees at a rate that will be published on the website of the university, and will also allow the university to take measures such as blocking services, not issuing approvals for studies and interruption of studies, in accordance with its instructions in this regard. Receiving a degree, recognition or academic approval will not detract from my obligation to pay the balance of my debts to the university. I know that welfare fees are optional payments and that if I do not notify, by the appointed time, of my choice not to pay welfare fees, I will be charged for their payment as an inseparable part of the tuition fee.
- 6. I know that a suspension of studies will come into effect only if and when the student's notification about it arrives in writing through the <u>In-Bar personal information system for students</u> under 'administrative requests', and I undertake to be in accordance with this.
- 7. Clicking "OK" on an electronic form on the university's website will obligate me, as if I were to confirmed this in writing.

- 8. I am responsible for all university property that comes into my possession or that I use, I will immediately report to the university any damage to said property or for its loss, and I will pay to the university any payment/compensation/fine due to damage/delay in return, in accordance with the instructions.
- 9. I know that the goals and direction of the university is to foster and promote learning and research in all branches of Torah and science in the spirit of Israel's Torah and Israel's tradition. The university does not intervene in a person's faith and opinions, but it expects everyone who comes through her gates to behave respectfully in the institution and respectfully to others. I undertake to behave in a way that respects the customs of the university and to follow the acceptable practice that arise from its special nature.
- 10. I give my consent for my name to be included in the lists of courses, students, and graduates to be published by the university. I know that upon completion of my studies my details will be stored in the graduate database by the university for documentation and maintaining contact.
- 11. The details I gave to the university will be used for the purpose of my studies at the university and the relationship between me and you the university, including for sending information on behalf of the university through electronic messages. Electronic and short message messages about programs and study tracks, scholarships and awards, activities at or on behalf of the university, including enrichment activities, culture and leisure, services and benefits for students. I am aware that I may at any time announce my removal from the mailing list of advertisement messages, by selecting the appropriate option that will appear at the bottom of those messages.
- 12. I agree that my personal information will be transferred to the National Insurance Institute, in order to apply a discounted rate for students.
- 13. I agree to the delivery of my personal information to the Council for Higher Education as well as to non-commercial entities. The purpose of the application is to contribute to the well-being of the student, such as, for example, grants or scholarships.
- 14. I know that some of the services, to which the welfare fee payers are entitled, are provided by the Student Association, Bar-Ilan University (hereafter: "Student Association"), and that for this purpose the following details of the welfare fee payers are forwarded to the Student Association: full name, ID number, study programs, email address and cell phone number.
- 15. My statements and commitments above and below refer to all years of study at the university, and various registration activities such as setting up a study program schedule, registering for courses, etc. every year, will not deduct or void from it's validity.
- 16. I agree that the university will receive from any source, any information about my past studies, including any grades, matriculation exams, psychometric exams, academic studies, certification studies, etc., subject to the fact that the university will keep the information in accordance with the provisions of any law and will use it exclusively for my candidacy and studies, or for research and statistics needs. Same as, I agree that the university will transfer information about my educational achievements to the National Institute for Testing and Evaluation (NITE) for research purposes.
- 17. The courts in the Tel-Aviv district were granted unique local jurisdiction in any claim between me and the university.
